### PROPRIETARY NAME, STRENGTH AND PHARMACEUTICAL FORM DERMIKELP® ITCH RELIEF CREAM

Please read this leaflet carefully because it contains important information for you:

- Keep this leaflet. You may need to read it again.
- Do not share **DERMIKELP® ITCH RELIEF CREAM** with any other person.
- Ask your pharmacist if you need more information or advice.
- You must see a doctor if your symptoms worsen or do not improve after ten days.

#### 1. WHAT **DERMIKELP® ITCH RELIEF CREAM** CONTAINS

Each gram contains 375 mg of *Ecklonia maxima* (sea kelp) as active substance. The other ingredients are benzyl benzoate, caprylyl glycol, *Cananga odorata* (ylang-ylang) flower oil, cetearyl alcohol, cetearyl glucoside, citric acid, ethylhexylglycerin, gluconolactone, isopropyl myristate, linalool, paraffinum liquidum, PEG-20 stearate, phenoxyethanol, sodium benzoate and water (aqua).

#### 2. WHAT **DERMIKELP® ITCH RELIEF CREAM** IS USED FOR

**DERMIKELP® ITCH RELIEF CREAM** soothes itchy irritated skin and is suitable for the symptoms associated with eczema (dry, inflamed, irritated skin), contact dermatitis (skin rash after touching something), seborrheic dermatitis (scaling skin rash), minor insect bites and allergic skin reactions caused by soaps, detergents, cosmetics and jewellery.

#### 3. BEFORE YOU USE **DERMIKELP® ITCH RELIEF CREAM**

**Do not use **DERMIKELP® ITCH RELIEF CREAM**:**  
If you are hypersensitive (allergic) to *Ecklonia maxima*, iodine or any of the other ingredients of **DERMIKELP® ITCH RELIEF CREAM** (see **WHAT **DERMIKELP® ITCH RELIEF CREAM** CONTAINS**).

#### Take special care with **DERMIKELP® ITCH RELIEF CREAM**:

If you have broken skin areas, **DERMIKELP® ITCH RELIEF CREAM** can cause a temporary burning or stinging sensation when you apply it to broken skin.

#### Pregnancy and breastfeeding:

If you are pregnant or breastfeeding, please consult your doctor, pharmacist or healthcare professional before using **DERMIKELP® ITCH RELIEF CREAM**. Safety during pregnancy and breastfeeding has not been established.

#### Driving and using machinery:

No studies have been done to establish the safety of **DERMIKELP® ITCH RELIEF CREAM** during driving a vehicle or operating machinery. Do not drive a vehicle, operate machinery, or do anything else that require your attention until you know how **DERMIKELP® ITCH RELIEF CREAM** affects you.

#### Using other medicines with **DERMIKELP® ITCH RELIEF CREAM**:

Always tell your healthcare professional if you are taking any other medicine (this includes complementary or traditional medicines).  
Do not use **DERMIKELP® ITCH RELIEF CREAM** in combination with other topical applications (such as creams or ointments) unless otherwise indicated by your healthcare professional.

#### 4. HOW TO USE **DERMIKELP® ITCH RELIEF CREAM**

For external use only.  
Always use **DERMIKELP® ITCH RELIEF CREAM** exactly as instructed. You should check with your doctor or pharmacist if you are unsure.  
Apply to the affected area as required. Massage gently into your skin to ensure proper absorption.  
**DERMIKELP® ITCH RELIEF CREAM** can be used daily as required.  
If you have the impression that the effect of **DERMIKELP® ITCH RELIEF CREAM** is too strong or too weak, talk to your doctor or pharmacist.

#### If you use more **DERMIKELP® ITCH RELIEF CREAM** than you should:

If you or your child accidentally ingested **DERMIKELP® ITCH RELIEF CREAM**, consult your doctor or pharmacist. If neither is available, contact the nearest hospital or poison centre.  
Take this leaflet and the rest of the remaining cream with you so the doctor will know what you have taken.

#### If you forget to use **DERMIKELP® ITCH RELIEF CREAM**:

Apply daily as required.

#### 5. POSSIBLE SIDE EFFECTS

**DERMIKELP® ITCH RELIEF CREAM** can have side effects.  
**Not all side effects reported for **DERMIKELP® ITCH RELIEF CREAM** are included in this leaflet. Should your general health worsen or if you experience any untoward effects while using **DERMIKELP® ITCH RELIEF CREAM**, please consult your doctor, pharmacist or other healthcare professional for advice.**

If any of the following happens, stop using **DERMIKELP® ITCH RELIEF CREAM** and tell your doctor immediately or go to the casualty department at your nearest hospital:

- Swelling of your hands, feet, ankles, face, mouth or throat, which may cause difficulty in swallowing or breathing.
- Rash or itching.
- Fainting.

These are all very serious side effects. If you have them, you may have had a serious allergic reaction to **DERMIKELP® ITCH RELIEF CREAM**. You may need urgent medical attention or hospitalisation.

Tell your doctor if you notice any of the following:

- Slight redness of your skin.
- If you notice any side effects not mentioned in this leaflet, please inform your doctor or pharmacist.

#### 6. STORING AND DISPOSING OF **DERMIKELP® ITCH RELIEF CREAM**

- Store at or below 25 °C.
- Protect from sunlight.
- Keep container tightly closed.
- Do not remove from outer carton until required for use.
- **STORE ALL MEDICINES OUT OF REACH OF CHILDREN.**
- Do not use after the expiry date printed on the label or carton.
- Return all unused medicine to your pharmacist.
- Do not dispose of unused medicine in drains and sewerage systems (e.g. toilets).

#### 7. PRESENTATION OF **DERMIKELP® ITCH RELIEF CREAM**

White, plastic tube/jar packed into an outside carton.  
Pack sizes: 25 g, 50 g, 100 g and 500 g.

#### 8. IDENTIFICATION OF **DERMIKELP® ITCH RELIEF CREAM**

Off-white to beige cream with characteristic odour.

#### 1. **WAT **DERMIKELP® ITCH RELIEF CREAM** BEVAT**

Elke gram bevat 375 mg *Ecklonia maxima* (seevier) as aktiewe bestanddeel. Die ander bestanddele is bensielbensoaat, *Cananga odorata* (ylang-ylang) blomolie, etielheksielgliserien, fenoksiëtanol, glukonolaktone, isopropielmiristaat, kapriëlglukol, linalool, mineraalolie, natriumbensoaat, PEG-20 steeraat, setearielalkohol, setearielglukosied, sitroensuur en water.

#### 2. **WAARVOOR **DERMIKELP® ITCH RELIEF CREAM** GEBRUIK WORD**

**DERMIKELP® ITCH RELIEF CREAM** streel joukende, geïrriteerde vel en dit is geskik vir die simptome geassosieer met ekseem, kontakdermatitis, seborree-dermatitis, minder ernstige insekbyte en allergiese velreaksies veroorsaak deur sepe, skoonmaakmiddels, grimering en juweliersware.

#### 3. **VOORDAT JY **DERMIKELP® ITCH RELIEF CREAM** GEBRUIK**

**Moet nie **DERMIKELP® ITCH RELIEF CREAM** gebruik nie:**  
Indien jy hipersensitief (allergies) vir *Ecklonia maxima*, jodium of enige van die ander bestanddele van **DERMIKELP® ITCH RELIEF CREAM** is (kyk **WAT **DERMIKELP® ITCH RELIEF CREAM** BEVAT**).

#### **Neem spesiale sorg met **DERMIKELP® ITCH RELIEF CREAM**:**

Indien jou vel stukkend is, **DERMIKELP® ITCH RELIEF CREAM** mag 'n brand- of steeksensasie veroorsaak wanneer dit aangewend word op plekke waar die vel stukkend is.

#### **Swangerskap en borsvoeding:**

Indien jy swanger is of borsvoed, konsulteer asseblief jou dokter, apteker of gesondheidsorgdeskundige voordat jy **DERMIKELP® ITCH RELIEF CREAM** gebruik.  
Veiligheid tydens swangerskap en borsvoeding is nie bepaal nie.

#### **Bestuur en die gebruik van masjinerie:**

Geen studies is uitgevoer om die veiligheid van **DERMIKELP® ITCH RELIEF CREAM** te bepaal terwyl 'n voertuig bestuur of masjinerie hanteer word nie. Moenie 'n voertuig bestuur, masjinerie hanteer of enigiets anders doen wat jou aandag vereis totdat jy weet hoe **DERMIKELP® ITCH RELIEF CREAM** jou beïnvloed nie.

#### **Die gebruik van ander medisynes saam met **DERMIKELP® ITCH RELIEF CREAM**:**

Slegs vir uitwendige gebruik.  
Gebruik altyd **DERMIKELP® ITCH RELIEF CREAM** presies volgens die aanwysings. Kontroleer met jou dokter of apteker indien jy onseker is.  
Wend aan die aangetaste oppervlak, soos nodig. Masseer sagkens in die vel in, om te verseker dat dit voldoende geabsorbeer word.  
**DERMIKELP® ITCH RELIEF CREAM** kan daagliks gebruik word, soos nodig.  
Indien jy die gevoel kry dat die effek van **DERMIKELP® ITCH RELIEF CREAM** te sterk of te swak is, praat met jou dokter of apteker.

#### **Indien jy meer **DERMIKELP® ITCH RELIEF CREAM** gebruik as wat jy behoort:**

Indien jy of jou kind per ongeluk **DERMIKELP® ITCH RELIEF CREAM** ingeneem het, raadpleeg jou dokter of apteker. Indien nie een van hulle beskikbaar is nie, kontak die naaste hospitaal of gifsentrum.  
Neem hierdie inligtingsblad en die oorblywende room saam met jou sodat die dokter kan weet wat jy geneem het.

#### 5. **MOONTLIKE NEWE-EFFEKTE**

**DERMIKELP® ITCH RELIEF CREAM** kan newe-effekte hê.  
**Nie alle newe-effekte wat vir **DERMIKELP® ITCH RELIEF CREAM** aangemeld is, word in hierdie inligtingsblad ingesluit nie. Indien jou algemene gesondheid agteruitgaan of indien jy enige ongunstige effekte ervaar terwyl **DERMIKELP® ITCH RELIEF CREAM** gebruik word, konsulteer asseblief jou dokter, apteker of ander gesondheidsorgdeskundige.**

Indien enige van die volgende gebeur, hou op om **DERMIKELP® ITCH RELIEF CREAM** te neem en sê onmiddellik vir jou dokter of gaan na die ongevalle-afdeling by jou naaste hospitaal:

- Swelling van jou hande, voete, enkels, gesig, mond of keel, wat probleme met sluk en asemhaling kan veroorsaak.
- Uitslag of gejeuk.
- Floutes.

Hierdie is alles baie ernstige newe-effekte. Indien jy dit het, mag jy 'n ernstige allergiese reaksie op **DERMIKELP® ITCH RELIEF CREAM** gehad het. Jy mag dringende mediese bystand of hospitalisasie nodig hê.
